4. **AGM Presentation**

Members of the Board provided a recap of the season for their respective oversight areas. Tanya Foley (TF), Executive Director, provided a recap of the 2018/19 season and a look ahead at the upcoming season.

5. Director Reports

No questions were raised about the Director reports previously circulated.

6. Financials

Kristine Simpson presented the findings of the audit conducted by BDO Canada.

 "In our opinion, except for the possible effect regarding the completeness of donations, the financial statements present fairly the financial position of the Vancouver Thunderbirds Association for the year ended March 31, 2019 and the results of its operations and its cash flows for the year then ended in accordance with ASNPO."

Frank Nishi, VTMHA Secretary/Treasurer, provided a summary of the financial statements from the 2018/19 season which resulted in an excess of revenue of \$108K. The 2019/20 season budget has been set with a \$40K net loss in order to: 1) reduce the association's overall net assets which is currently \$267K; 2) reduce the overall impact of the increasing costs and decreasing overall registrations; and 3) invest in player development.

Steve Gully provided an in-depth look at how registration fees within divisions were spent last season and how they will be spent next season.
